


# Port Authority receives USEPA grants

"This funding will bolster our overarching initiative to revitalize 500 urban industrial acres located within corridors of legacy heavy manufacturing concentration."

US Environmental Protection Agency announced it has selected the Port of Greater Cincinnati Development Authority for two brownfields assessment grants. The Port Authority has been awarded \$300,000 from USEPA Brownfield 2017 Assessment Grant funding.

- Community-wide hazardous substances grant funds will be used to conduct eight Phase I and four Phase II environmental site assessments, and create three cleanup plans.
- Community-wide petroleum grant funds will be used to conduct five Phase I and three Phase II environmental site assessments, and create two cleanup plans.

Grant funds of both types also will be used to maintain and update an inventory of brownfield sites, and support community outreach activities. The Port Authority submitted its grant request application in December 2016, citing the need for focused redevelopment efforts in the Mill Creek and Interstate 75 inner city highway corridors.

Price Hill proposed as next for Port Authority rehab program

Mayor John Cranley has recommended including funding in the City of Cincinnati's 2018-19 budget for the Port Authority to expand its targeted revitalization initiative to the Price Hill neighborhood. On May 25, Mayor Cranley said he was proposing to take the Port Authority's successful REACH program to Price Hill with a grant of \$2,280,610 -"that will be used for both residential and commercial revitalization from Glenway to West Eighth Street and everything in between." Ken Smith, Executive Director of Price Hill Will, joined the Mayor at his announcement of his FY budget recommendations, which outlined a variety of investments for city neighborhoods including Avondale, College Hill, Bond Hill, Westwood and Evanston.

REACH stands for Rehab Across Cincinnati and Hamilton County – and since 2015, the Port Authority has managed the complete transformation of over 20 vacant historic homes and sold them. REACH has made such an amazing impact in Evanston that we have expanded the program to Walnut Hills – with plans to expand to new Cincinnati neighborhoods in 2017 and beyond.

Over the past month, three new families now call Walnut Hills home having moved into the first three REACH homes in the neighborhood. The next two REACH homes in Walnut Hills will be on the market soon - there will be an open house at 747 and 751 Morgan this Sunday, June 4 from 12 - 2 PM.

The Port Authority this month completed the sale of 3.1 acres in Roselawn to the developer that will build Roselawn Senior Apartments, an \$8.2 million independent senior housing project. The Port Authority acquired the site in 2014 as a donation in order to eliminate the vacant, blighted commercial structure that previously existed.
