

Hamilton County Landbank Home Program Application

Thank you for your interest in the Hamilton County Landbank Home Repair Program. This program is designed to provide assistance to eligible **single or two-family owner-occupied** houses. Currently, the program is available to **Village of Lincoln Heights** residents who need financial assistance to meet building standards of safe, sanitary, and decent housing. Eligible homeowners can receive up to \$15,000 in exterior repair work while funds are available.

Applicant Eligibility:

Upon submittal of a complete application, an Applicant must satisfy each of the following requirements:

- A. The property must be in "fee simple" ownership status.
- B. The Applicant should be a homeowner with income *at or below* **80% AMI**. (\$83,850 for a household of four)
- C. The Applicant must require exterior repair work to preserve their home's value and meet local zoning and building codes.
- D. The Applicant must be current with real estate taxes (or be on an active payment plan) and mortgage payments.
- E. The Applicant, including any entity related to the Applicant, must not have been a defendant in a foreclosure action within the last five years.
- F. The Applicant must be a homeowner living in the subject property for **10+ years.**

A title search will be conducted to verify the Applicant's ownership and the tax status of the Property.

D. GENERAL TERMS OF HOME REPAIR PROGRAM:

- A. Maintenance: The Applicant must maintain the property up to the County's building code standards after the Home Repair assistance.
- B. The Hamilton County Landbank will select and engage the contractor to perform the repairs.
- C. A title search is required and will be provided by the program at no cost to the Applicant.
- D. A License Agreement and Release will be required to be signed by the Applicant prior to the commencement of work.
- E. A Completion Certificate must be signed by the Applicant and the contractor following the completion of the work.

E. REQUIRED DOCUMENTATION:

Please submit the following **required** information with your application.

- □ A copy of Valid Government Identification reflecting the address
- □ A copy of the declaration page of homeowner's insurance that identifies the amount of homeowner's insurance, date of coverage, and amount of premium.
- □ A copy of the most recent mortgage statement that reflects the mortgage balance, payments, and escrow information.
- □ A copy of the most recent tax returns, or documents certifying Applicant's annual income
- □ A copy of the notice of code orders from the local municipality (not required)
